The Reading Scholarship Foundation Inc. (**RSF**) provides financial assistance to selected students who are continuing their full-time education. The amount of these awards is determined primarily on the basis of need. The applicant's, as well as the family's, financial resources are considered in this decision. RSF will determine eligibility for a scholarship based on the information provided on the application and information from the **Free Application for Federal Student Aid (FAFSA)**. That information is your **Student Aid Report (SAR)** which includes your **Expected Family Contribution (EFC)**. An example of this information is located on the last page of this **RSF** application.

Additionally, high school seniors and college transfer students will need to complete an Application Supplement. RSF will mail the Application Supplement in **April 2019**. Applicants need to complete and postmark the Application by the date indicated on the Application Supplement.

**Applications that do not meet the requirements or deadlines will be rejected.** All information submitted to RSF is held in strict confidence. Applications are numbered upon receipt and all family names are deleted to assure anonymity.

The Awards Committee will carefully review all the information supplied in the application as well as from the FAFSA SAR. This will include any special family or business circumstances you include with the application. The Awards Committee will notify all applicants by mail when a decision has been made concerning their application.

Based on the information we have on record for you, your EFC is 001056. You may be eligible to receive a Federal Pell Grant and other federal student aid.
